These community service initiatives have advanced the mission of the Foundation in both direct and indirect ways. In 2000 the Key Initiative Focus and Past Presidents Advisory Council projects also broadened the Foundation's programming experience.

Since 2012, New Fellows have had the opportunity to advance the Foundation's mission by participating in hands-on philanthropic opportunities with grantees, regional projects and leveraging prior Class projects. Some examples are:

Speaking Opportunities



Represent OSBF through Speaking Opportunities

Throughout the school year, OSBF receives requests for presentations from parent groups, nonprofits, service groups, schools, and other entities. Our Fellows fulfill these requests by using prepared and customizable presentations.

The Foundation's mission is to promote the public understanding of the law and improvements to the justice system. Since cyber bullying, sexting, and turning 18 can have significant legal impacts on students, OSBF wants to speak with students to ensure they understand their rights and responsibilities.

There are plenty of opportunities throughout the year that OSBF will contact Fellows about. However, feel free to be proactive and reach out to set up your own. The Foundation can make all arrangements for you to speak, including a staff member to help present.



B4USend is an interactive PowerPoint presentation for use in classrooms. During the presentation, an OSBF Fellow and staff member will discuss the issues surrounding cyber bullying and sexting.

It is a free presentation that can be tailored to small and/or large groups and also includes parent presentations. Close to 8,000 students statewide have already learned about the legal aspects that can impact their futures when living in a digital world.

Freedom. Independence. What's not to like about becoming 18? In the eyes of the law, the age of 18 is considered an adult. An individual can vote, run for office, serve, on a jury, and make many other decisions about the future. Yet, many "new adults" often lack a legal understanding of what they can and cannot do concerning today's hot button issues:

- Living Digitally
- Having Fun
- Encountering Police
- Handling Money Matters
- Moving Out
- Managing Medical Issues
- Considering Sex
- Getting Married & Having Kids

FWD@18 includes a free presentation around each of these topics that can be mixed and matched to fit an organization's specific needs. Each one is appropriate for those who aren't 18 yet and to those who are beyond the age but who may still be uncertain about their legal responsibilities as college students or new employees in the workplace. These presentations also give great insight to parents and guardians helping those making the transition to adulthood.

RULES & REGS



ARTICLE I NAME AND PURPOSE

SECTION 1. NAME AND PURPOSE. The name of this organization is "Ohio State Bar Foundation" (the "Foundation"). The Foundation is a nonprofit corporation under Ohio law, organized for educational, literary, scientific and charitable purposes. The Foundation shall be known and considered as "the Professional Honorary of Ohio Lawyers." As the charitable arm of the Ohio State Bar Association (the "Association"), the Foundation advances the philanthropic interests of Ohio's lawyers by recognizing excellence, improving the justice system and enhancing public understanding of the rule of law.

ARTICLE II MEMBERSHIP

SECTION 1. MEMBERS. Except as provided hereunder the members of this organization shall be its Fellows. The membership year of the Foundation shall be determined from time to time by the Board of Trustees ("Foundation Year").

- A. FELLOWS' SELECTION. Fellows' membership in the Foundation is a professional honor. Fellows shall be selected by the Board of Trustees from those members of the Association whose professional, public, and private careers have demonstrated outstanding dedication to the welfare of the community and the maintenance and support of the major objectives of the Foundation. Fellows shall aid in carrying forward the work of the Foundation and in maintaining the objectives of the Foundation. In addition to Fellows selected by the Board of Trustees, officers and members of the Board of Governors of the Association shall be eligible to be nominated as Fellows.
- (1) **LIFE FELLOWS.** Fellows who have completed the required contributions in effect at the time of their acceptance as a Fellow in accordance with this Article shall be Life Fellows.
- (2) **DISTINGUISHED LIFE FELLOWS.** Distinguished Life Fellows shall be Life Fellows who have continued their support of the Foundation through contributions of not less than a cumulative amount of \$5,000.
- (3) OTHER FELLOWS CATEGORIES. From time to time, the Board of Trustees may provide for additional recognition levels for Distinguished Life Fellows based on total contributions to the Foundation.
- **B. INVITATION AND ACCEPTANCE.** The President shall extend an invitation to each person eligible for Fellows membership under this Article. Each person accepting the invitation shall become a Fellow upon receipt by the Foundation of his or her signed acceptance form and his or her initial required contribution, if applicable. Each person accepting such invitation shall be furnished with a copy of these Regulations. The next required contribution shall be paid in the succeeding Foundation Year and remaining required contributions shall be paid in succeeding Foundation Years until fully paid.
- C. **REQUIRED CONTRIBUTIONS OF FELLOWS.** Except as otherwise provided in this Article, each Fellow shall contribute annually to the Foundation such amount and according to such payment schedule as may be determined by the Board of Trustees from time to time. Life Fellows and Honorary Fellows shall not be obligated to make required contributions.



Required contributions may be prepaid, in whole or in part, at any time at the rate of contribution in effect for the Foundation Year in which the prepayment is made. All contributions shall be available for use at the discretion of the Foundation. In no event shall the Foundation be required to refund any contribution or part thereof. Fellows' contribution statements shall be sent to Fellows annually. If a Fellow resigns, such Fellow is not obligated to make further contributions to the Foundation.

- D. LATE PAYMENT OF REQUIRED CONTRIBUTIONS. The late payment of a required contribution shall be handled as provided under policies adopted by the Board of Trustees. Such policy or policies shall include procedures regarding a late payment, non-payment, payment deferral, payment cancellation, membership suspension and membership termination.
- **E. HONORARY FELLOWS.** Incumbent Justices of the Supreme Court of Ohio, persons who are recipients of statewide Foundation awards, and such others who have been designated by the Board of Trustees shall be eligible to be nominated as Honorary Fellows of the Foundation without further qualification.

An Honorary Fellow receives recognition but is not obligated to make a required contribution and is not eligible to vote at any meeting of Fellows of the Foundation. If an Honorary Fellow makes a voluntary contribution he or she shall be treated as a Fellow for that Foundation Year so long as the contribution is at least equal to the amount set forth by the Board of Trustees and its policies. Such an Honorary Fellow will be considered a voting member for that Foundation Year. If an Honorary Fellow complies with Article II Section 1 A

(1) he or she will thereafter be considered a Life Fellow.

ARTICLE III MEETINGS OF FELLOWS

SECTION 1. ANNUAL MEETING OF FELLOWS. As provided in Chapter 1702 of the Ohio Revised Code ("Chapter 1702") the Foundation shall hold an Annual Meeting of Fellows. The President shall set the specific date, time and place of such meeting. At such Annual Meeting:

- A. The Fellows shall elect such number of Trustees as may be designated by the Nominating Committee, each to serve a three-year term beginning on the first day of the Foundation Year next following his or her election (nominations for persons to be elected to such terms shall be made as provided by Article IV of these Regulations);
- B. The Fellows shall receive a report of the activities of the Foundation;
- C. The Fellows may grant such awards as are determined by the Board of Trustees; and
- D. The Fellows may transact such other business that may properly be brought before the meeting.

SECTION 2. SPECIAL MEETINGS OF FELLOWS. Special meetings of the Fellows may be held at any time upon call of the President or any five members of the Board of Trustees. The date, time, place and purpose(s) of any such meeting shall be stated in the notice thereof.

SECTION 3. NOTICE OF MEETINGS OF FELLOWS. Notices of meetings of Fellows shall be provided as required and as provided by Chapter 1702.



SECTION 4. VOTING. For purposes of acting on any matter properly submitted to the Fellows for their vote, consent, waiver, release or other action, each Fellow in good standing shall have one vote. Attendance, participation, and voting at any meeting of the Fellows shall be limited to those Fellows present in person.

SECTION 5. QUORUM FOR MEETING OF FELLOWS. At any meeting of Fellows, those Fellows present in person shall constitute a quorum.

ARTICLE IV BOARD OF TRUSTEES

SECTION 1. COMPOSITION. The business and affairs of the Foundation shall be managed by a Board of Trustees consisting of the following Fellows:

- A. The President, President-Elect, and Immediate Past President of the Foundation, none of whom, while holding any such office, shall be subject to the term limits imposed upon other Trustees by these Regulations;
- B. The President and President-Elect of the Association, each for a two-year term commencing on the first day of the Foundation Year following his or her election as President-Elect, neither of whom, while holding either such office, shall be subject to the term limits imposed upon other Trustees by these Regulations;
- C. Up to fifteen additional Trustees elected by the Fellows from nominees presented in accordance with this Article; and
- D. The Executive Director of the Association, who shall serve as an ex officio non-voting member of the Board of Trustees.

SECTION 2. TERMS, LIMITATIONS, AND VACANCIES.

- A. Except as otherwise provided in these Regulations, each Trustee shall serve a three-year term commencing on the first day of the Foundation Year next following his or her election. No Trustee shall serve more than two consecutive three-year terms, but service in a consecutive partial term to fill a vacancy shall not be considered for purposes of such limitation.
- B. A Fellow who has served as a Trustee for the maximum period permitted by paragraph A of this Section 2 shall not be eligible for election as a Trustee for two Foundation Years after such maximum period has expired.
- C. Vacancies in the Board of Trustees, including any vacancy created when a Trustee assumes the office of President-Elect, or due to the resignation, death or removal of a Trustee, shall be filled by vote of the Board of Trustees from a slate of candidates (which may consist of a single name) presented to the Board by the Nominating Committee.



SECTION 3. COMMITTEES

- A. **EXECUTIVE COMMITTEE.** The Executive Committee shall consist of the President, Immediate Past President, President-Elect, Chairs of Standing Committees and Treasurer. Between meetings of the Board of Trustees, the Executive Committee shall exercise the power and authority of the Board of Trustees in the management of the Foundation. The Executive Committee is subject to the authority and direction of the Board of Trustees.
- B. NOMINATING COMMITTEE. The President of the Association, the President, two Fellows appointed by the President of the Association and one Fellow appointed by the President shall constitute the Nominating Committee. The President shall designate the chairperson of the Nominating Committee. The Nominating Committee shall nominate candidates for election as Trustees and for election to the offices of President-Elect, Treasurer and Secretary, subject to approval of the Board of Trustees. In the event that failure of one or more of the members of the Nominating Committee to vote results in a tie vote of the Nominating Committee, the President may appoint a Fellow to serve on the Nominating Committee in place of the Nominating Committee member who failed to vote.
- C. NOMINATION OF CANDIDATES FOR ELECTION AS TRUSTEES. The Nominating Committee shall prepare a slate of nominees consisting of one candidate for each opening that will exist on the Board of Trustees as of the first day of the succeeding Foundation Year, as a result of the normal expiration of a board term. The chairperson of the Nominating Committee shall present the slate to the Secretary no later than thirty days prior to the Annual Meeting of Fellows, which slate shall be noticed to the Fellows no less than twenty days prior to the Annual Meeting of Fellows. The Nominating Committee shall make a report of the slate at the Annual Meeting. Additional nominations may be made by writing, signed by any twenty-five Fellows in good standing and delivered to the Secretary no later than ten days prior to the Annual Meeting of Fellows.
- D. NOMINATION OF CANDIDATE FOR ELECTION AS PRESIDENT-ELECT. Each Foundation Year, the Nominating Committee shall nominate to serve as President-Elect a Fellow who is a Trustee at the time of nomination and will have served at least three full years on the Board of Trustees at the time such person's term as President-Elect would begin. The term of President-Elect shall begin on the first day of the succeeding Foundation Year. The Nominating Committee shall make its report of such nomination to the Secretary no later than thirty days prior to the date scheduled for the final regular meeting of the Board of Trustees in the then-current Foundation Year. Nominations from the floor at that meeting shall be accepted. Election of the President-Elect shall be conducted by the Board of Trustees as provided in Article V, Section 2 of these Regulations.
- E. **OTHER COMMITTEES.** The Board of Trustees, or the Executive Committee, may designate such other committees as are necessary or desirable, and may define the duties and powers of such committees. At any meeting of such committee, its members may participate in person or by authorized communications equipment as provided in Article XI of these Regulations.



SECTION 4. MEETINGS OF THE BOARD OF TRUSTEES

- **A. REGULAR MEETINGS.** Regular meetings of the Board of Trustees shall be held at least quarterly. The date, time, and place of each meeting shall be stated in the notice, which shall be provided to each Trustee at least ten, but not more than thirty, days before the meeting.
- **B. SPECIAL MEETINGS.** Special meetings of the Board of Trustees may be held at any time, upon the call of the President, or any five Trustees. At least two days' written notice shall be given of any special meeting, and such notice shall state the date, time, place, and purpose(s) of the special meeting.
- **C. QUORUM FOR THE BOARD OF TRUSTEES AND THE EXECUTIVE COMMITTEE.** At any meeting of the Board of Trustees, or the Executive Committee, a majority of either body, present and participating in person or by authorized communications equipment as provided in Article XI of these Regulations, shall constitute a quorum. NOTICE. Notices of meetings shall be provided as required or permitted by Chapter 1702.
- **D. MANNER OF ACTING BY THE BOARD OF TRUSTEES AND THE EXECUTIVE COMMITTEE.** The act of a majority of the members of the Board of Trustees, or the Executive Committee, participating in person or by authorized communications equipment as provided in Article XI of these Regulations, at a meeting at which a quorum is present, shall be the act of that particular body.
- **E. ACTION WITHOUT MEETING.** Any action which may be taken at any meeting of the Board of Trustees, or of any committee there, may be taken without such meeting by a writing or writings signed by all the members of the Board or of such committee. The writing or writings evidencing such unanimous action taken without a meeting shall be filed with the Secretary and inserted by the Secretary in the permanent records of the Foundation.

ARTICLE V OFFICERS

SECTION 1. COMPOSITION AND QUALIFICATION. The officers of the Foundation shall be a President, a President-Elect, an Immediate Past President, a Secretary, a Treasurer, and such other officers as the Board of Trustees deems proper. The offices of Secretary and Treasurer may be held by the same person. The President, President-Elect and Immediate Past President shall be Fellows. No other officer shall be required to be a Fellow or a member of the Board of Trustees.

SECTION 2. ELECTION. At the final regular meeting of the Board of Trustees in each Foundation Year, the Trustees shall immediately following the report of the Nominating Committee regarding its nomination for President-Elect as provided in Article IV, Section 3 D of these Regulations, elect one of their number as President-Elect. If there is no incumbent President-Elect at that time, the Trustees shall also elect one of their number as President. At such meeting, the Trustees shall also elect a Secretary, a Treasurer, and such other officers as they deem proper. Notwithstanding the foregoing, if such meeting is not held or if any such officer is not elected thereat, such officer may be elected at any regular meeting of the Trustees or at a special meeting called for that purpose.



SECTION 3. TERMS OF OFFICE.

- A. **PRESIDENT.** The President shall hold office for a term of one year and until his or her successor is elected and qualified, or until his or her earlier resignation, removal from office or death. Such term shall commence on the first day of the second succeeding Foundation Year following his or her election as President-Elect (or if there is no incumbent President-Elect, such term shall commence on the first day of the Foundation Year following election as President) and shall expire on the last day of such Foundation Year.
- B. PRESIDENT-ELECT. The President-Elect shall hold office for a term of one year and until his or her successor is elected and qualified, or until his or her earlier resignation, removal from office or death. Such term shall commence on the first day of the Foundation Year following his or her election and shall expire on the last day of such Foundation Year, or upon succession to the office of President. The President-Elect shall automatically succeed to the office of President upon expiration of the term or until his or her earlier resignation, removal from office or death of his or her predecessor President.
- C. **OTHER OFFICERS.** Each other officer shall hold office for a term of one year and until his or her successor is elected and qualified, or until his or her earlier resignation, removal from office or death. Such term shall commence on the first day of the Foundation Year following his or her election and shall expire on the last day of such Foundation Year.
- D. **MISCELLANEOUS.** Notwithstanding the foregoing, the term of office of any officer (even if actually shorter than one year) shall commence, or be deemed to have commenced as of the first day of the Foundation Year immediately following the date scheduled for the final regular meeting of the Board of Trustees referred to in Section 2 of this Article V.

SECTION 4. DUTIES.

- A. **PRESIDENT.** The President shall be the chairperson of the Board of Trustees and the chief executive officer, with such powers and duties as generally pertain to those offices. The President shall serve as an *ex-officio* member, with the right to vote, of every committee of the Foundation.
- B. **PRESIDENT-ELECT.** The President-Elect shall act as Vice President and shall have such authority and perform such duties as are customarily incident to such office, and such other duties as may from time to time be required of him or her by the Board of Trustees. In the absence or incapacity of the President, the President-Elect shall have the authority and shall perform the functions of the President.
- C. **OTHER OFFICERS.** The other officers shall have such authority and perform such duties as are customarily incident to their respective offices, and such other and further duties as may from time to time be required of any such officer by the Board of Trustees.

SECTION 5. REMOVAL. All officers shall serve at the pleasure of the Board of Trustees and any officer may be removed with or without cause by the affirmative vote of two-thirds of the Trustees present and voting at a regular meeting, or a special meeting called for that purpose, whenever the Trustees determine that the best interests of the Foundation would be served thereby.



ARTICLE VI COMPENSATION

The Foundation may pay reasonable compensation to its employees and agents for services rendered in effecting its purposes, provided that such compensation is approved by the Board of Trustees or by the Executive Committee. No Fellow, Trustee, or officer of the Foundation shall receive, or become lawfully entitled to receive, from the Foundation any part of its net income, provided that nothing herein shall prevent any Trustee, officer, or employee from being reimbursed for reasonable out-of-pocket expenses incurred in conjunction with the business of the Foundation.

ARTICLE VII PROPERTY AND INVESTMENT

SECTION 1. PROPERTY. All property, whether real, personal, tangible or intangible, received by the Foundation, by contribution, bequest, devise, gift, grant, or otherwise, shall comply with any Gift Acceptance Policy of the Foundation in effect at the time of receipt and, if accepted in compliance with such Policy, shall be held by the Foundation, or disposed of by it, on terms and conditions consistent with any imposed by the donor and not inconsistent with the Articles of Incorporation, as the Board of Trustees shall determine.

SECTION 2. INVESTMENTS. Unless otherwise specified, restricted or limited by terms of a particular gift, bequest, devise, grant, or another instrument, the funds of the Foundation may be invested from time to time in such manner as the Board of Trustees, or the Executive Committee, shall deem advantageous, whether the investments are of a character which would be required by law for similar funds if held by a fiduciary.

ARTICLE VIII AMENDMENT

These Regulations may be altered, amended or repealed, and new Regulations may be adopted, by the affirmative vote of two-thirds of the Trustees present and voting at a regular meeting or a special meeting called for that purpose, followed by the affirmative vote of a majority of the Fellows present and voting at any meeting of the Fellows, provided that a description of the proposed alteration, amendment, repeal, or new Regulations (which may be set forth, all or in part, in summary form) is contained in the notices of both such meetings.

ARTICLE IX RECORD OF FELLOWS AND TRUSTEES

The Secretary shall maintain a record containing the names of all Fellows and Trustees, together with the last known address of each Fellow and Trustee. There shall also be stated therein the dates upon which each Fellow or Trustee held either such position, together with the reason(s) for removal or termination, if any. It shall be the duty of every Fellow and Trustee, upon becoming such, to furnish forthwith to the Secretary, for inclusion in such record, his or her then mailing address and other address, if any, for receipt of transmissions by authorized communications equipment, and likewise to report promptly to the Secretary for inclusion in such record any change in any such address.



ARTICLE X INDEMNIFICATION

SECTION 1. AUTHORIZATION. The Foundation shall indemnify its Trustees and officers to the full extent permitted by Chapter 1702, including advancement of expenses. The Foundation may, to such extent and in such manner as is determined by the Board of Trustees within its sole discretion, but in no event to an extent greater than is permitted by Chapter 1702, indemnify any employee, agent or other volunteer (as defined in Chapter 1702) of the Foundation permitted to be indemnified by Chapter 1702, or any person who is or was serving at the request of the Foundation as a trustee, director, officer, employee, member, manager, agent or volunteer of another corporation (domestic or foreign, nonprofit, or for profit), limited liability company, partnership, joint venture, trust or other enterprise.

SECTION 2. INSURANCE., To the extent permitted by Chapter 1702, the Foundation may acquire and maintain insurance or furnish similar protection including, but not limited to, trust funds, letters of credit or self-insurance for or on behalf of any person who is or was a Trustee, officer, employee, agent or volunteer (as defined in Chapter 1702) of the Foundation, or is or was serving at the request of the Foundation as a trustee, director, officer, employee, member, manager, agent or volunteer of another corporation (domestic or foreign, nonprofit, or for profit), limited liability company, partnership, joint venture, trust or other enterprise.

SECTION 3. LIMITATION. Anything to the contrary notwithstanding, the Foundation shall not indemnify members of the Board of Trustees, officers or other persons or entities, pay their expenses in advance or pay insurance premiums on their behalf if such indemnification payment, advance expense payment or payment of insurance premium: (if) would constitute a violation of any provision of the Internal Revenue Code, as amended (the "Code"), applicable to a private foundation, if the Foundation is so classified under the Code; or (ii) would constitute an "excess benefit transaction" under Section 4958 of the Code, if the Foundation is not classified as a private foundation under the Code.

ARTICLE XI USE OF AUTHORIZED COMMUNICATIONS EQUIPMENT

SECTION 1. AUTHORIZED COMMUNICATIONS EQUIPMENT. Authorized communications equipment may be used for the purpose of giving notice of: (I) meetings or any other notice required by Chapter 1702; (ii) attending and participating (including voting) in meetings of the Trustees and any Committee (but not attending, participating in, or voting at, any meeting of Fellows); and (iii) giving a copy of any document or transmitting any writing required or permitted under Chapter 1702. "Authorized communications equipment" shall have the meaning set forth in Chapter 1702.

SECTION 2. COMMUNICATIONS SENT BY AUTHORIZED COMMUNICATIONS EQUIPMENT.

Any communication sent to a Fellow or Trustee by authorized communications equipment shall be deemed properly delivered if sent to the address furnished by the Fellow or Trustee for transmissions by authorized communications equipment.

OSBF Grantmaking – Fueling Change in Your Community

The Ohio State Bar Foundation is a charitable grantmaking organization that awards grants to Ohio nonprofits addressing specific, unmet legal needs in their communities. Since 1992, OSBF has awarded more than \$12 million to law-related philanthropic organizations.

There are two grant application periods each year – one in the spring and one in the fall. The deadline for the Spring Grant Cycle is February 15 at 5 PM, and the deadline for the Fall Grant Cycle is August 15 at 5 PM. Grant applications can be submitted online and are reviewed and approved by OSBF's Board of Trustees.

One Grantee Story

Ohio State Legal Services Association | Southeastern Ohio Youth Law Project

The Southeastern Ohio Youth Law Project (YLP) was implemented by Southeastern Ohio Legal Services (SEOLS) in partnership with Sojourners Care Network (Sojourners) to address the need for civil legal aid for youth and young adults. The YLP was designed to remove legal barriers vulnerable youth face when transitioning into adulthood by providing education on legal rights and responsibilities, representation in legal proceedings and community outreach.

The Impact of YLP...

"Jake" is a 16-year-old boy who has ADHD and a learning disability. He's in the custody of children services. Over the last 2 years, Jake has had numerous foster care placements and has attended four different schools. Last fall, Jake was placed with a family who planned on adopting him. However, when he was disciplined at school for defending a friend who was attacked in a parking lot off school grounds and outside school hours, the foster family decided they were no longer willing to adopt him. Subsequently, Jake was sent to yet another foster home two counties away.

When Jake's new foster parent attempted to enroll him in a new school, Jake and the family were informed (for the first time) that he had been expelled from his previous school. The new school refused to enroll him. More important to Jake, he would miss tryouts for wrestling and wouldn't be able to compete in any winter sports. Neither Jake nor his foster parents were notified of the expulsion by the former school or children services, and the expulsion hearing was held without anyone there to represent him.

Thankfully, Jake's foster parents learned about the YLP and connected Jake to a SEOLS attorney who was able to challenge the expulsion. Jake was enrolled in school shortly thereafter and was able to participate in wrestling tryouts.



\$35,000 to Pro Bono Partnership of Ohio to increase technological and educational capabilities allowing access to legal services for more Ohio nonprofits and providing opportunities for corporate attorneys to impact their communities through pro bono service.

University of Cincinnati Foundation The Legal Access Project at Cincinnati Law District 1

IRA Charitable Rollover Information

On December 18, 2015, Congress passed the PATH Act 318 - 109 making the IRA Charitable Rollover a permanent incentive for charitable giving in the federal tax code. Previously, the provision was up for re-authorization every two years as part of the Pension Protection Act of 2006.

The IRA charitable rollover legislation allows you to transfer lifetime gifts up to \$100,000 from your individual retirement account (IRA) without undesirable tax effects.

You may contribute funds from your IRA if:

- You are age 70 ½ or older at the time of the gift.
- You transfer funds directly from your IRA. This opportunity applies to IRAs and not other types of retirement plans.
- You transfer funds outright to OSBF or other qualified charities. The legislation does not permit transfers to charitable trusts, donor advised funds or charitable gift annuities.

Awarded annually to a law student enrolled in one of Ohio's nine law schools this rotating fellowship award supports statewide legal education initiatives and programs for exceptional law students to instill in them the concepts of ethics, integrity and civility that Chief Justice Moyer personified.

Chief Justice Thomas J. Moyer Professorship for the Administration of Justice and Rule of Law. This endowed professorship at The Ohio State University Moritz College of Law honors and purports Chief Justice Moyer's legacy of integrity and professionalism, deepening the impact of these qualities on the lives of countless students and on the law itself.

Denny L. Ramey Education Fund - The Denny L. Ramey Education Fund was established in 2012 by the Foundation Board of Trustees to recognize 26 years of service to OSBF by Mr. Ramey as its Treasurer and his unwavering support of the Foundation.

The goal of this fund is to support educational projects in the Appalachian region of Ohio the further the educational purposes of the Foundation and public understanding of the law in the state of Ohio.

Friends and Neighbors Endowment (FANE) Fund - The FANE Fund was established in 2005 by the family of Linda Thompson Kohli in recognition of her 10 years as Executive Director of the Ohio State Bar Foundation. Proceeds from this restricted fund support Foundation programs.

Law & Leadership Fund - Established in 2009 by the Foundation Board of Trustees to support the Law & Leadership Institute (LLI).

This restricted fund supports LLI's commitment to strengthening the academic and leadership skills of Ohio high school students from under-served schools to improve college graduation rates and ultimately, establish a "pipeline" of students with the ability and the desire to diversify the legal profession.

LLI leverages the expertise, resources and collaborative efforts of Ohio attorneys, law schools, and law firms, bar associations, public school districts and private corporations to the benefit of more than 300 high school students in Ohio each year.



Ohio Lawyers Assistance Program Fund - The Ohio Lawyer's Assistance Program Fund was approved in 2013 by the Ohio State Bar Foundation Trustees.

The Lawyer's Assistance Program (OLAP) is dedicated to helping Ohio lawyers, judges, and law students obtain treatment for substance abuse, chemical dependency, other addictions and mental health issues.

The fund provides financial assistance to OLAP clients who lack the resources to pay for necessary treatment.

William K. Weisenberg Fund for Civics Education - The William K. Weisenberg Fund for Civics Education was established in 2013 by the Foundation Board of Trustees to recognize 35 years of service at OSBA by Mr. Weisenberg.

This Fund will provide financial assistance to promote civics education initiative that prepare school age children and young adults to better understand our constitutional democracy and provide them with the knowledge and tools they need to be better, more informed citizens.

The **Ramey Award for Distinguished Community Service** is given to an attorney who exemplifies integrity, honor, courtesy, and professionalism and whose career showcases dedication to the goals and values of the Foundation and service to the public and community. Service must be outside the recipient's practice of law and done without compensation.

The **Outstanding Program or Organization Award** is given to a program or organization that promotes the distribution of information about, increases access to, and/or generates improvements in the Ohio justice system.

The **Community Service Award for Attorneys 40 & Under** is presented to attorneys, 40 and younger, who contribute a substantial amount of their time and talents to their communities through volunteering and other service opportunities. Service must be outside the recipient's practice of law and done without compensation. NOTE: This award is presented to honorees in each of the OSBA's 18 districts in the spring and fall each year. The *statewide* award recipient is chosen from the pool of district honorees.
