The Position

The Development Director will:

- be a strategic and dynamic fund development leader;
- have a deep understanding of fundraising principles, methods, and tactics;
- be highly collaborative and a strong motivator for the Board, Fellows, and staff; and
- be able to establish effective relationships with the legal and justice community; foundation Fellows; and corporate, foundation, and individual donors.

Key Position Functions

Fund Development Strategy and Planning – Creates and implements an overall strategy and plan for fund development. Establishes objectives to increase the level of giving to the organization. Communicates the strategy and serves as liaison to the Board's development committee.

Development and Fundraising Tactics – Develops fundraising tactics and tools to achieve OSBF fundraising goals and objectives. Implements fundraising activities for:

- Annual Giving (broad-based, digital giving, direct mail, annual campaign)
- Major Giving
- Planned Giving (Legacy Campaign)
- Law Firm, Corporate, and Foundation Giving
- Campaigns (e.g., capital campaign)
- · Sponsorships and Event Fundraising

Donor Relations and Stewardship – Develops and maintains strong relations with donors, funders, legal community, and the corporate sector. Initiates and maintains positive relationships with donor prospects, current donors, and past donors. Develops appropriate and respectful donor development, solicitation, and stewardship plans. Guides and leads volunteers and executive staff in identifying and developing donors.

Culture of Philanthropy and Case for Support – Develops and communicates a clear and compelling case for supporting the Ohio State Bar Foundation. Promotes a culture of philanthropy with the foundation's Fellows, staff, Board, volunteers, as well as Ohio State Bar Association members and the greater legal community to increase the number of donors and level of giving. Collaborates and partners closely with all functional areas of the organization to encourage, connect, and support philanthropic giving.

Fund Development Operations – Supports an infrastructure to enable giving to the OSBF, including: donor data tracking and reporting, donor relations, gift acknowledgement and gratitude activities, donor solicitation tracking, and gift and fundraising policies and processes. Establishes, monitors, and reports on the development activity and budget. Ensures the Executive Director and Board receive accurate, timely, and meaningful donor giving reports.

Development Communications – Assists the Communication Manager with writing, production, and distribution of targeted communications for fund development. Works closely with marketing to ensure that the Foundation's brand and voice is included in all development materials.



Community Relations – Represents OSBF in the community. Speaks to outside groups, constituents, and stakeholders to raise the level of awareness of OSBF initiatives and how philanthropic giving supports the organization and impacts justice initiatives across the state.
